Reports:

Cheri report:

This month we're at 100% save rate. We did not euthanize any animals except the owner requests. Things are starting to pick up as far as the humane care complaints now that the weather is starting to change. We have about 25 dogs in the facility and 30 cats.

Mr. Trentman: Do you have open cages?

Cheri: With only 26 of them filled, we have about 25 empty dog kennels. About 5 open cat cages right now.

Mr. Trentman: Sound like things are going good. Is this time of year we expect it to be good?

Cheri: With the weather starting to get colder. Animals that have been out the majority of the year without shelter, now when the weather starts getting cold, people will call the dogs outside without shelter. So we'll start completing more humane care investigations.

Mr. Trentman: How is the adoption center doing?

Cheri: She adopted out all the dogs that she had in the adoption center last week. We have dogs in the quarantine section. As soon as they've gone through their quarantine period, they will be available for adoption.

Mr. Trentman: Rescues are pulling when they can?

Cheri: Yes.

Mr. Trentman: I want to thank my friend, Steve and Brittany Galle from Lenzburg. They donated 60 bales of straw to Gateway Pet Guardians and BAHS. Over the weekend, we dropped it off down at Marty Crawford's property. We're set up for that. Again, I'd like to thank Steve Galle from Lenzburg for doing that.
