Cheri report:

For the month of August we're at 98%. So far this month, Ashley has done 12 adoptions and also I wanted to let you know our Veterinarian/Administrator will not be renewing the contract.

Mr. Trentman: Do we have open kennels?

Cheri: Yes. We have one side is open except for one dog and we have open cat cages. They're coming in and they're going, either back home or to rescues.

Mr. Trentman: Have you noticed anything with Covid? Any problems?

Cheri: No, I don't feel that we've had a problem with it. In the very beginning we had a couple people call and say "take my dog, I can't keep it". We ask what we ask everyone "have you tried adoption facilities first?" Then they say, "Well, I have Covid". So we get their information and we check with Herb Simmons and it just happened to be that the one or two people who did this, there were no reported, positive cases at the address. But there was one dog we did take, it was the husband's dog, his wife couldn't take care of it. It was a chained dog in the backyard. He did have Covid and passed away. It had been several weeks since he had passed and the dog was outside and hadn't been around him. We did go and get that dog.

Mr. Trentman: Ashley's not here, but you said the adoptions are going ok?

Cheri: Yes they're going ok. I think this month it's a little slower. I don't know if it's because of the change with schools, now they're not home. I guess they're going part time. I do know that she does have some other applications pending. I know that number will go up before the end of the month.

Mr. Trentman: Do we get any volunteers come through to walk dogs?

Cheri: Yes, we have volunteers come on a regular basis. They have their set days. The main group of volunteers that she has they don't miss a day even if it's raining or starting to get cold. They'll still be out there.
