Attorney Report: Attorney Kevin Kaufhold stated that he is currently working through several FOIA requests submitted to the ETSB. He is also working on litigation matters. No action needs to be taken by the ETSB Board at this time.

Director's Report:

Items For Information:

Monthly Call Statistics: Assistant Director Bryan Whitaker referred to the call statistics for the ETSB Board to review.

PSAP Consolidation Update: Assistant Director Whitaker informed the ETSB Board that there were two meetings of the Statewide 9-1-1 Advisory Board scheduled for both March and April 2021. ETSB staff remotely attended the March meetings and the first April meeting. The second April meeting was cancelled.

Staff remotely attended two additional meetings coordinated by Advisory Board Member Linda Zerwin, who represents counties with populations over 250,000. Discussions included proposed changes to the Emergency Telephone Systems Act, which is scheduled for renewal by December 31, 2021. The primary bill, which has support from the both the Advisory Board and 9-1-1 Agencies, has passed the Public Utilities Committee. The bill is currently on the House Floor. There has been no movement on the shell bill which is being utilized to carry the agreed upon modifications. The bill does not yet have the support of the 9-1-1 Advisory Board. Additionally, ETSB staff has been working closely with the ETSB consultant concerning other legislative changes that impact 9-1-1.

Items for Action:

Omnigo Software Contract Renewal: Assistant Director Whitaker requested the ETSB Board's approval in renewing the contractual agreement with Omnigo Software for the Computer Aided Dispatch contract. ETSB staff was able to negotiate a 3 year contract at a cost of \$184,202.83 to be paid in 3 annual installments, with an overall savings of \$18,412.99. Sheriff Watson asked for a motion to approve the renewal of the Omnigo Software contract for 3 years for a total cost of \$184,202.83. A motion was made by Don Feher and seconded by Kevin Elbe. The motion passed unanimously.
