July was 96% save rate. We had 9 adoptions. We returned 34 back to owners. Right now, we have seven dog kennels open and 10 cat cages that are open.

Mr. Trentman: Did it flood down there?

Cheri: The creek didn't. We had a roof leak, and the path flooded and the ditch lines. It was close to the top, but it didn't flood.

Mr. Trentman: How are the rescues? Are they coming and picking up animals?

Cheri: They came today for evaluations. They normally come in the morning, but they decided to come this afternoon and it was raining. So, I think they're coming back on Wednesday to evaluate them at the park.

Mr. Trentman: When I'm up and down that street, I see volunteers walking and at the park across the road. That's good to see. Adoptions were 9? Is that average?

Cheri: Since Covid they've been lower. In August there are more than July, but I don't know the final count. We just moved out of quarantine some cute little dogs. I'm sure they'll go fast.
