#### ST. CLAIR COUNTY SHERIFF DEPARTMENT

Report for the month of December 1, 2021, ending December 31, 2021, included the following data: Average Daily Population was 485, inmates admitted 428 of those 125 were females, 303 males, 141 misdemeanors, 197 felons, 3 federal, 65 fugitives, Sentence Weekend Bookings 4, Sentence County Bookings 6, D.O.C 9 and Other 1. On the patrol side for the month of December 2021 there were 277 traffic citations, 98 traffic warnings, 74 felony/misdemeanors, 36 warrant arrests, 334 park patrol, 1,227 business checks and 173 courthouse check for a total of 959 points of contact with the public.

#### ST. CLAIR COUNTY CLAIMS

Per the St. Clair County Claims Report the following data was reported. There were four (4) personal Injury claims, and four (4) property claims for the month of December.
