We can all get together and come up with a plan to get animals moving out of our facility into adoption centers quickly. We're going to be using the conference room at BAHS.

We also had a meeting with Gateway Pet Guardians and Bob was there. The next week, we had a meeting with BAHS, some of their members and also Shelly Korves who is a board member along with Bob.

Mr. Trentman: I'm trying to pave the way to move animals out.

Mr. O'Donnell: Are any of those individuals doing TNR "Cat and release"?

Cheri: There is an organization that started out St. Clair TNR and Rescue. This year they haven't been doing as many as in the past, so we have another organization called Sterilization Nation who have two appointments per week with Lashley Animal Hospital. Those two groups. St. Clair TNR was taking their cats to Hartz Second Chance. When they're not filling the appointments, they are contacting the other organization to fill them.
