Call to Order

Public Comment: None

Cheri Report:

The month of October we had 11 adoptions. 32 RTO and our Save rate was 100%. The Calls are getting busier with the weather changing. Bite cases last week, you would have thought it was after the holiday. We had 12 bite cases in 5 days.

Mr. Trentman: Can you take us through a normal bite case from start to finish?

Cheri: If a person is bitten and seek medical attention, by law, the medical provider is required to send us a bite report. Or if the police are called, we'll take a police report. If the pet's rabies vaccination is current, it will be issued a 10 day home confinement. The owner's have to keep it away from the public for 10 days. At the end of the 10 days it will be examined and "cleared" by the Veterinarian. Once the Veterinarian signs off on the paperwork and it is sent to our office, the case is closed. Even though the animal is current on rabies, they also have to be registered with the county.

If the animal that bit rabies vaccine is not current, then we give the owner the option to either quarantine the animal with us or with a licensed Veterinarian. Most of them choose Animal Services because some Veterinarians do not quarantine bite cases. We hold the animal for 10 days. At the end of 10 days the veterinarian will examine it, clear it and when they pick the animal up, it will be current on its rabies vaccine, microchipped and registered with the county.

Hollingworth: Is there times when the animal has to be put to sleep in these cases?

Cheri: With a bite case and quarantining with us, it is up to the owner to reclaim or request the animal to be euthanized. We let them know we will not adopt out an animal that we know to have bitten. They would sign paperwork to either reclaim or authorization for euthanasia. But it is their choice.

Mr. O'Donnell: Is this different than animal on animal bites?

Cheri: Animal on animal attacks are treated differently than animal to person bites. With animal to animal, most of the time one of the animals if not both were off their property at the time. Whichever one was off the property, we talk to the owner.

O'Donnell: They're liable?

Cheri: Yes. We do talk to them about running at large. We make sure they're current on their rabies vaccination and registration. If they are not, we give them 15 days to get that done.
