Report for the month of October 1, 2021, ending October 31, 2021, included the following data: Average Daily Population was 515, inmates admitted 462 of those 122 were females, 340 males, 139 misdemeanors, 217 felons, 6 federal, 81 fugitives, Sentence Weekend Bookings 4, Sentence County Bookings 2, D.O.C 11 and Other 2. On the patrol side for the month of October 2021

there were 137 traffic citations, 94 traffic warnings, 81 felony/misdemeanors, 43 warrant arrests, 345 park patrol, 1,249 business checks and 162 courthouse checks for a total of 1,151 points of contact with the general public.
