#### **Cheri Report:**

The save rate was 97% 33 animals were returned to owners. We adopted out 13 animals in the month of September. Our kennels are staying full. We only have 6 dog kennels open and 2 cat kennels open.

Mr. Trentman: I heard there are a lot of feral cats there.

Cheri: Right now, we have a lot of nice cats. Normally it's the opposite.

Mr. Trentman: Maybe it was a couple of week ago.

Cheri: Yes, we had some leave to a rescue but now about 80% are all friendly.

Mr. Trentman: do you have any barn cats?

Cheri: Do you know someone looking for some?

Mr. Trentman: I could probably use some. If you have one, that would be good.

Cheri: Ok. If none of these that we have right now would be good for a barn, as soon as we get one, we can figure that out.

Mr. Trentman to Matt Ludgate: How are things going?

Matt: Calls have been steady.

Mr. Trentman: What do you do there?

Matt: I'm an animal control officer. I have been there for about fifteen years now.

Mr. Hollingsworth: I have a question. Are cats more vulnerable to die than dogs when they're there? Are they hard to deal with, because I know they're kind of finicky? Are they more hard to deal with than dogs?

Cheri: The true feral cats are harder to handle. But with cats, the problem we have a lot of time: they don't handle change well. So when they come into a kennel environment, they can get very stressed. If they have an underlying condition that will bring it out. Sometimes they will stop eating and then we'll have to try different things to stimulate their appetite. Where normally a dog comes in, they can adjust quickly. The smaller dogs,

little house dogs, sometimes they are really scared. We might have to entice them by mixing soft and hard food.

Mr. Hollingworth: Thank you.

Mr. Trentman: We had a cat from the Humane Society. He was kind of feral. The first 6 months you couldn't get within 10 feet in front of it. The longer that it's been in the barn, I feed it every day. Now it will come up and you can scratch it's back a little bit. He still pulls away. But after a year, being around the barn and hanging out. He'd doing better now. I guess they're doing their job. We haven't seen a mouse in like 20 years around the place. Matt, what were you saying, what all do you do down there?

Matt: We go on calls, different types of calls, Stray reports, Humane care (complaints), pick up strays contained. We also have bite cases. We have to quarantine them, depending on their rabies shots, (if they are current or not). This week, I have been helping out with the cleaning. We have a couple people on vacation. I also help with euthanasia for owner requests.
