Call to order by Public Safety Committee Chairman Jerry Dinges at 6:30 p.m., followed by the Pledge of Allegiance.

There were no comments from the public regarding the Public Safety Meeting's Agenda.

Chairman Jerry Dinges asked for approval of the August 30, 2021, Public Safety Committee Meeting's Minutes. There being no questions it was moved by Steve Gomric and seconded by CJ Baricevic to approve the August 30, 2021, minutes, and place them on file. Motion Carried.

#### ST. CLAIR COUNTY JUVENILE DETENTION CENTER

Frank Bergman began with reading the St. Clair County Juvenile Detention Report, "Please be advised, as indicated by Superintendent Lawrence Brazil's Population Report, that we did not exceed the D.O.C rate capacity of 38 for the reporting period of September 18, 2020, through October 15, 2021. If you have any questions about this matter, please contact Superintendent Brazil." Noted: The new Superintendent is Lawrence Brazil.

There being no questions it was moved by Steve Gomric seconded by CJ Baricevic and the report placed on file. Motion Carried.

## ST. CLAIR COUNTY EMERGENCY MANAGEMENT AGENCY (EMA)

Due to the absence of Herb Simmons, Frank Bergman read the E.M.A Report for August / September 2021. He stated the following information:

- 1. All monthly radio tests were conducted, and no problems were noted.
- 2. All outdoor warning siren tests were conducted, and no problems were noted.
- 3. St. Clair County Mobile Command Post was deployed to support Police Operations at standoff/shooting in East St Louis.

- 4. St. Clair County Mobile Command Post was deployed to support Oktoberfest in Belleville.
- 5. Continue to attend the Weekly Hospital/EMS COVID 19 Conference Calls
- 6. Attend the weekly Conference call with IEMA Director regarding COVID-19
- 7. Attending regional radio communications meeting with Metro Partners
- 8. Attended the Monthly Starcom 21 Committee Meeting
- 9. Continue to conduct the Weekly COVID-19 Live Facebook Briefings
- 10. Staff participating in planning of Regional Tabletop Exercise related to Cyber Security.

There being no questions, it was moved by CJ Baricevic and seconded by Steve Gomric and the report-placed on file. Motion Carried.

### ST. CLAIR COUNTY SHERIFF DEPARTMENT

Lt. Lee Graham presented report for the month of August 2021 which included the following data: Average Daily Population was 489, inmates admitted 433 of those 89 were females, 344 males, 112 misdemeanors, 225 felons, 8 federal and 72 fugitives. On the patrol side for the month of August 2021 there were 243 traffic citations, 78 traffic warnings, 90 felony/misdemeanors, 26 warrant arrests, 299 park patrol, 1,292 business checks and 152 courthouse checks for a total of 2,180 points of contact with the general public. There being no questions it was moved by Dave Langford and seconded by Steve Gomric and the report is placed on file. Motion Carried.

#### ST. CLAIR COUNTY CLAIMS

Frank Bergman read the St. Clair County Claims Report. Frank recommended that the two Intergovernmental Agreements between County of St. Clair and City of Belleville, Illinois and County of St. Clair and the Village of Millstadt, Illinois be referred to the Judiciary Committee. There being no questions it was moved by Steve Gomric and seconded by CJ Baricevic and the report placed on file. Motion Carried.
