Mr. Meile made a motion seconded by Mr. Allen to approve the minutes from the 7-18-2022 meeting. All members present voted aye.

Resolutions:

- A) Resolution approving the appropriation of \$1,889,685.00 from Motor Fuel to make the 2023 Bond Payments. These bonds are the Highway Revenue Bond Series 2020D. Mr. Crawford made a motion seconded by Mr. Allen to approve. All members present voted aye.
- B) Resolution granting permission to Vero Fiber Networks LLC to install a fiber optic line north on the west side of North Lincoln, CH 43, for 4030 feet then east on the south side of O'Fallon-Troy Road, CH 45, 5,342 feet. Mr. Meile made a motion seconded by Mr. O'Donnell to approve. All members present voted aye.
- C) Resolution approving the award for the design and plans related to the bridge replacement of the Plum Hill Bridge over Loop Creek, structure 082-4102, in Shiloh Valley Township to Oates and Associates, Inc. at a cost-plus fixed fee in the amount of \$75,642.00. The cost of the engineering work for this section, 22-17105-02-BR, to be split between the Township Motor Fuel Tax Fund and County Rebuild Illinois Funds. Mr. Allen made a motion seconded by Mr. O'Donnell to approve. All members present voted aye.

- D) Resolution approving the additional use of Township Bridge Project Funds to the sources previously approved for the Midgley-Ness Bridge over Silver Creek know as Section 21-09103-01-BR. Mr. Allen made a motion seconded by Mr. O'Donnell to approve. All members present voted aye.
- E) Resolution authorizing an additional \$50,000.00 from the County's Highway Fund for the preliminary engineering work on the Green Mount Road widening Section 13-00333-15-PW. Mr. O'Donnell made a motion seconded by Mr. Meile to approve. All members present voted aye.
- F) Resolution authorizing a no-bid contract to a specialized contractor for emergency bridge repair to the structure on Scott-Troy Road, CH 61, under the CSX RR. This bridge was damaged by a Tire Service boom truck. Mr. O'Donnell made a motion seconded by Mr. Allen to approve. All members present voted aye.
- G) Resolution authorizing the purchase of 1-F150 truck, 1-F250 truck and 1 F350 dump truck in the total amount of \$140,565.00 under section 22-00000-05-EQ. Funding source would be the Highway Equipment Trust Fund. Mr. Crawford made a motion seconded by Mr. Allen to approve. All members present voted aye.
- H) Resolution authorizing the purchase of a used CAT 262D3 Skid Loader for \$58,750.00, Section 22-00000-06-EQ. The funding source would be the Highway Equipment Trust Fund. Mr. Meile made a motion seconded by Mr. O'Donnell to approve. All members present voted aye.
- I) Resolution authorizing the execution of an agreement between St. Clair County, The City of O'Fallon and Lake St. Ellen LLC to construct a road, sidewalk, curb and gutter and ancillary items over County owned property easterly of Old Collinsville Road.
