# TRUSTEE COMMITTEE MEETING - AUGUST 24, 2022

# 1. MINUTES:

A motion was made by Mr. Mosley, Jr., and seconded by Mr. Greenwald to approve the minutes of the July 13, 2022, Trustee Committee Meeting. Motion carried.

### 2. TAX AGENT'S REPORTS AND RESOLUTIONS:

- a. Revolving Account Activity: The Revolving Account Activity Report for July 2022 shows a Beginning Balance of \$62,098.51, Receipts of \$9,553.78, Total Disbursements of \$7,647.54, Allocated Pool Interest in the amount of \$3.64 with a Balance at Month End of \$64,008.39.
- b. Payment Account Activity: The Payment Account Activity Report for July 2022 shows a Beginning Balance of \$876,167.37 and a Balance at Month End of \$958,820.50.

### c. Monthly Redemption Reports:

#### 5. **OTHER BUSINESS:**

Mr. Strohmeyer informed the committee that 830 Centreville Avenue and Union is up for auction and waiting from the Illinois EPA about clean up on the property. Committee decided to hold on putting it in the auction until IEPA says that cleanup project is complete. Mr. Strohmeyer gave information to the committee about a proposition from Spivey.
