For the year of 2021, we brought in 1619 animals into the facility. We returned to owner 330. We did 141 adoptions. Our live save rate was 98%.

Mr. Trentman: Great news. How's everything going down there? Do we have kennels open?

Cheri: We have some open. We just ran into an issue trying to put animals into the adoption center. We have to get the right fit for the staff that works there. Today we were able to get three more into quarantine. We have three out that are all nice dogs. Mike O'Donnell's wife was in Friday and they adopted a cat.

Mr. Trentman: Is anyone still pulling animals like they normally do?

Cheri: Gateway and the Humane Society, mostly. Over Christmas, I think Gateway gives their fosters a break so there's a couple weeks waiting period, but they're catching up.
