ST. CLAIR COUNTY EMERGENCY MANAGEMENT AGENCY (EMA)

Per the E.M.A Report for January 2022 / February 2022. The following information was reported

12. Conducted the monthly meeting of the St. Clair County Emergency Telephone Systems Board and welcomed new Board member Mayor GW Scott Sr.
13. Attended the Statewide 9-1-1 Next Generation 9-1-1 planning meeting.
14. Met with local Police Chief's and PSAP Managers concerning 9-1-1 activities.
15. Attended the Army Corps of Engineers Spring Flooding Preparedness.
16. Finalized contract negotiations with CENCOM Telecommunicators and ratified a 3-year agreement.

ST. CLAIR COUNTY SHERIFF DEPARTMENT

Report for the month of January 1, 2022, ending January 31, 2022, included the following data: Average Daily Population was 483, inmates admitted 448 of those 107, were females, 341 males, 147 misdemeanors, 192 felons, 12, federal, 61 fugitives, Sentence Weekend Bookings 15, Sentence County Bookings 6, D.O.C 9 and Other 6. On the patrol side for the month of January 2022 there were 220 traffic citations, 67 traffic warnings, 40 felony/misdemeanors, 26 warrant arrests, 301 park patrol, 1,211 business checks and 141 courthouse check for a total of 936 points of contact with the public.

Per the St. Clair County Claims Report the following data was reported. There were four (4) personal Injury claims, and two (2) property claims for the month of January.
