Cheri Report:

The save rate was 98%. Our Dog kennels are full and we have 15 cat kennels open.

Mr. Trentman: are people coming through for adoptions?

Cheri: Adoptions are picking up. So far this month, we have 15.

Mr. Trentman: What do you think the ratio is for dogs, a lot of Pitbulls?

Cheri: Majority of pitbulls or mixes.

Mr. Wilhelm: What do you do when the kennels are full?

Cheri: We can't take any in until they go home or are pulled by rescues.

Mr. Hollingsworth: Have you been putting any animals to sleep lately? Cats, dogs?

Cheri: Only if it's an "owner request" for illness or aggression. We're "no-kill".

Mr. O'Donell: That kitten we got is something else. She's all over the place. She's a good cat.

Mr. Trentman: Who is all pulling animals? Gateway and the Humane Society?

Julie: The humane society has other endevours and GPG is full a lot of the time so we get backed up.

Mr. Trentman: How many has the humane society pulled in the last couple of weeks?

Julie: Yeah, The usually take several every week. Two weeks ago they didn't take anything for two weeks because they took animals from other states. This week they're not taking anything.

Cheri: Last week they took 5, dogs and cats.

Mr. Greenwald: Do they get requests for that or do they look out of state?

Julie: Both. Kathy Bissell does a lot of animal rescue through the Bissell foundation. They do a lot of work with Rural communities and ask for help all across the United

States. Many rescues will take animals from Mississippi, Arkansas, places where there are less options for those animals.

Cheri: They had a load of animals come up. BAHS was the drop off and they took the ones they were scheduled to get and the St. Louis APA came to the humane society to pick their animals up.

Mr. Trentman: Are there any events coming up throughout the country? Didn't you guys go one time?

Cheri: Conferences? Not that we're going to. I think you're thinking of Best Friends conferences.

Julie: The next one is in July in North Carolina.

Mr. Trentman: Adoptions are good. Are those kennels full over there?

Cheri: Yes. We've been able to keep the quarantine section more full and as they're getting adopted, moving animals to the adoption center. Lately, once they become available, we have multiple applications for them.

Mr. Trentman: Did you fill the open position?

Cheri: Yes. The warden position is filled and the kennel position is in the process of being finalized.

Mr. Trentman: The kennel position is for both sides, AC and adoption center?

Cheri: No.

Mr. Trentman: Who do we have over there?

Cheri: Ashley and Jordan. Jordan was there before Ashley went on maternity leave. She was there by herself during that time. In fact if you haven't looked at their facebook page lately, Jordan's been revamping it a little bit. They have Fun-Fact-Friday. It's nice.

Mr. Hollingsworth: I have a question about the seminar. Is it like a seminar where you might have a law or ordinance there that might change?

Cheri: No. What Bob is talking about is a national organization called Best Friends. They deal with nationwide animal rescue organizations and animal welfare communities with helping animal control facilities. As far as laws, Department of Agriculture and the Illinois Animal Control Association.
