Rescues are pulling, GPG and BAHS are our main rescues and not really much else. We have a 99% save rate this month, or last month. We created a new Facebook page for the Animal Services portion of the building and that seems to be working pretty well. We are implementing a new program for the TNR of feral cats and that seems to be working very well. And we have got a couple new people hired. Lots of calls, lots of animals, kennels are full.

Ashley: Still. I sent an email today because they were supposed to be delivered this week. And he said that it got pushed back a couple more weeks. So probably looking at mid-December. But that will probably be end of December. But its been 4 months.

Ashley: Its been tough because we have nothing where it is supposed to be, so we are all running around over everything, but its ok. We are not going to know what to do when we have cabinets.
