Nothing in this Ordinance hereby adopted shall be construed to affect any suit or proceeding impending in any court, or any rights acquired, or liability incurred, or any cause or causes of action acquired or existing, under any act or ordinance hereby repealed by this Ordinance, nor shall any just or legal right or remedy of any character be lost, impaired or affected by this Ordinance.

<u>SECTION 4: PASSAGE AND PUBLICATION</u>. This Ordinance shall be in full force and effect from and after its passage and publication by the County Clerk as provided by law.
