New Business:

- Approval of recommendation on Outdoor Warning Siren Purchase to replace and expand the outdoor warning sirens within St. Clair County.

Approved - There being no questions it was moved by Susan Gruberman and seconded CJ Baricevic. Motion Carried.

There were no comments from the public regarding the Public Safety Meeting's Agenda.

ST. CLAIR COUNTY JUVENILE DETENTION CENTER

12. The FEMA Federal Disaster Declaration was received for the July 2022 Flooding. Disaster Resource Centers have opened in East St Louis and Caseyville. The Deadline to apply is December 16, 2022. To date, more than 4,500 have applied and 12.9 million dollars of assistance has been provided.
13. A kickoff meeting was held with the selected vendor for the outdoor warning sirens along with the Community and Public Safety leaders.

ST. CLAIR COUNTY SHERIFF DEPARTMENT

Report for the month of October 1, 2022, ending October 31, 2022, included the following data: Average Daily Population was 457, inmates admitted 494 of those 126 were females, 368 males, 181 misdemeanors, 213 felons, 9 federal, 77 fugitives, 2 Sentence Weekend Bookings, 5 Sentence County Bookings 7, D.O.C 11 and Other 0. On the patrol side for the month of October there were 159 traffic citations, 100 traffic warnings, 80 felony/misdemeanors, 332 park patrol, 1,519 business checks and 130 courthouse checks for a total of 1,029 points of contact with the general public.
