The cost plus amount not to exceed \$117,140.00 and be funded from the County's Rebuild Illinois Funds. Mr. Trentman made a motion seconded by Mr. Crawford to approve. All members present voted aye.
- D) Resolution approving an agreement with the City of O'Fallon to install license plate readers on the traffic signal mast arms at North Greenmount and Central Park/Green Mount Crossing. Mr. Crawford made a motion seconded by Mr. Meile to approve. All members present voted aye.
- E) Resolution approving the addition of a portion of Old IL Route 158 to the County Highway System.
