- > 2019 Special Park Projects: Requests for payments have been processed during the last month on various projects.
- > 2021 Special Park Projects: Requests for payments have been processed during the last month on various projects.

Joe Hemphill from Volkert reported that they are meeting with Ameren about electrical services for the gate at Silver Creek and putting the gate back up at the right of way near the entrance.

Mr. Buehlhorn reported demolition crew hit the gate at Engelmann. Hank's finished clearing at Silver Creek and has gone to some of the other parks to do some clearing. Mr. Buehlhorn asked the committee if he should continue with the clearing now rather than in the spring if funds allow. The committee agreed that the clearing should continue now.
