# TRUSTEE COMMITTEE MEETING - December 13, 2023

### 1. MINUTES:

A motion was made by Mr. Hollingsworth and seconded by Mr. Greenwald to approve the minutes of the November 15, 2023, Trustee Committee Meeting. Motion carried.

#### 2. TAX AGENT'S REPORTS AND RESOLUTIONS:

- a. Revolving Account Activity: The Revolving Account Activity Report for November 2023 shows a Beginning Balance of \$126,624.42, Receipts of \$16,531.32, Total Disbursements of \$0, Allocated Pool Interest in the amount of \$331.21 with a Balance at Month End of \$143,486.95.

Mr. Mosley Jr. asked about the difference in silent vs open bids because many people have asked if we would ever go back to open bids. Mr. Strohmeyer said before COVID only the largest counties had the live bids, and the other counties were sealed bids. Mr. Strohmeyer said the biggest thing from the sealed bids is escrow is paid off quicker, deeded to the person quicker and subject to the next year tax. Mr. Strohmeyer said that results have been the same with the sealed bids as they were with the live auctions.
