ST. CLAIR COUNTY JUVENILE DETENTION CENTER

- 5. Attended the Monthly Starcom 21 Committee Meeting
- 6. Conducted weather briefings via social media regarding snow events.
- 7. Attended the STARRS Board Meeting.
- 8. Attended the Statewide Interoperable Executive Committee Meeting.
- 9. Attended the Statewide 9-1-1 Next Generation 9-1-1 planning meeting.
- 10. Attended meeting of the Statewide 9-1-1 Advisory Board.
- 11. Attended the monthly meeting of the St. Clair Special Emergency Services.
- 12. Meeting was held with Outdoor Warning Siren vendor and installs are expected to begin by the end of March.
- 13. Staff attended a planning meeting for the 2023 air show at Scott Air Force Base.
- 14. Many departments are receiving their deliveries from the bulk radio purchase and programming is underway.

ST. CLAIR COUNTY SHERIFF DEPARTMENT

Report for the month of February 1, 2023, ending February 28, 2023, included the following data: Average Daily Population was 455, inmates admitted 422 of those 103 were females, 319 males, 120 misdemeanors, 200 felons, 6 federal, 76 fugitives, Sentence Weekend Bookings 5, Sentence County Bookings 3, D.O.C 3 and Other 9. On the patrol side for the month of February 2023 there were 160 traffic citations, 30 traffic warnings, 48 felony/misdemeanors, 39 warrant arrests, 279 park patrol, 993 business checks and 104 courthouse check for a total of 870 points of contact with the public.
