## **Ashley Report**

Mr. Trentman: Report from our AC director, Ashley Jett.

Ashley: Of course, not much different than normal. We are full. We did have a 95% save rate for this month, or last month. I'm sorry. We didn't have too many leave the building. As far as going home purposes, we only had 5 animals returned to owner. We did 12 adoptions for that month. As far as transferring to other rescue organizations, we only had 29 leave via rescue transfer. We are pretty low on the spectrum of leaving. Everything is really slow. Everybody, again everybody is feeling this. We are not the only ones.

Mr. Trentman: How is the air working. Good on that end of the building?

Ashley: Yes. It's just hot outside. Last week anyways. I think we have had 299 animals total since the end of June that have left and went to animal rescues. So rescue transferred out of the building, which is still drastically lower than what we would normally be at this point in time. Typically by mid year, I am closer to the 5-600 animal region. We are at half of that.

Mr. Trentman: So how many transfers are you at as of now.

Ashley: 299

Mr. Trentman: So 300, so you are at least 200 out.

Ashley: Yes, about 2-300 down from what we normally are.

Mr. Trentman: And we are full right.

Ashley: Every kennel is full. We are removing more animals from humane care situations, abandonment situations, condemning situations. We just had 5 brought in last week from a condemned house in Dupo that we had to find space for.

Mr. Trentman: What can people do to help? How is the volunteer program looking?

Ashley: Our volunteer program numbers are still pretty much the same as it normally is. We have been putting out a couple of volunteer bulletins just to see about people coming down but ultimately I think every rescue around here needs fosters to take animals. They cannot pull anymore than what they have capacity for at their shelter. So, we need large dog fosters.

Mr. Trentman: And we could use volunteers down at the shelter?

Ashley: Yes. We are trying to boost that program but it's just not taking off.

Mr. Trentman: If someone wanted to help out, what time would they need to be down there?

Ashley: Any time.

Mr. Trentman: Whenever, just show up?

Ashley: Yes. 8:30-5:00

Mr. Trentman: Just go down and grab you a dog.

Ashley: We just have a brief training session with you. Then we will get you a dog you can walk down the street, go across the street to the play yard, anything – spend some time with some cats. Anything would help benefit our staff. We are super short staffed again. I had a full staff and now I am short staffed again.

Mr. Trentman: So anyone who has time, go down there, spend an hour or two every other week just to walk a dog. You can actually get you a dog, walk across the street, shut the gate and turn it loose. Ashley, do you still have a bench over there to sit on?

Ashley: I have a bench and a swing. A patio swing, so you can sit over there and swing while you hang out with a dog.

Mr. Trentman: Throw a frisbee or play catch or whatever. Sounds like you are doing what you can do, right?

Ashley: We are trying to focus more on, trying to simplify our processes in the office too with potentially a new software program. We have been talking with IT about it and we are trying to see if we can make it work budget-wise for next year. The one that I really is a lot of money, and it probably wont be beneficial for us to have. It would be beneficial for the girls in the office because its essentially zero to no input time. It's just that I can't, with the amount out money that it costs. We are going to try to look at this other version of what we have and make it work. It will make it more simplified for everyone who works there.

Mr. Trentman: Maybe if we knew someone at the newspaper, BND, maybe they could do some local flashes for volunteers needed or something. If they called you, you could give them instructions, right?

Ashley: Yes.

Mr. Trentman: Like a little ad or something.

Ashley: I can call down and see.

Mr. Trentman: Lexi.

Lexi Cortez: I don't work in advertising.

Ashley: I can just call down there though, right. And see what they can do for us.

Mr. Trentman: Who would she call down there Lexi?

Mr. Trentman: When you figure it out, call them. Put a nice little local flash – volunteers needed and the times. Stuff like that, with an address...that would be great.
