Mr. Strohmeyer said a code enforcement official from Cahokia Heights asked about the process and who was responsible for tearing down burnt structures which lead to a conversation East St. Louis and Washington Park demolition program. Mr. Strohmeyer said when we tore down the school building it was before Cahokia Heights and was just Centreville at the time. Mr. Strohmeyer ran new numbers for Cahokia Heights if we wanted to adopt a similar program, it would generate about \$250,000 a year. Mr. Strohmeyer said this would be worth it if someone wanted to pursue it and get all the tax bodies to sign off and agree to the program. Mr. Crawford said he will discuss this further with Cahokia Heights to see if they would be interested.

Mr. Mosley, Jr. said the City of East St. Louis has already made payment to acquire the property next to the Spivey building and are going to demolish it. Mr. Mosley, Jr. said this is the property that was holding us up. Mr. Strohmeyer said once the demolition takes place we can revisit the issue.
