Report of Activities Emergency Readiness / Public Safety Committee February 2023 / March 2023

- 1. All monthly radio tests were conducted, and no problems were noted.
- 2. Monthly tests of the outdoor warning sirens were completed. City of Belleville had a failure on their entire system. They worked with the vendor and successfully tested two days later.
- 3. Continue to attend the monthly Hospital/EMS COVID 19 Conference Calls
- 4. Attend the bi-weekly Conference call with IEMA Director regarding COVID-19
- 5. Attended the Monthly Starcom 21 Committee Meeting
- 6. Conducted weather briefings via social media regarding snow events.
- 7. Attended the STARRS Board Meeting.
- 8. Attended the Statewide Interoperable Executive Committee Meeting.
- 9. Attended the Statewide 9-1-1 Next Generation 9-1-1 planning meeting.
- 10. Attended meeting of the Statewide 9-1-1 Advisory Board.
- 11. Attended the monthly meeting of the St. Clair Special Emergency Services.
- 12. Meeting was held with Outdoor Warning Siren vendor and installs are expected to begin by the end of March.
