Upon a motion by Commissioner Dinges and second by Commissioner Lee it was unanimously agreed to Approve the Regular Expense Claims Report with Payroll Ledger Report of November 30, 2023.

Upon a motion by Commissioner Dinges and second by Commissioner Lee, it was unanimously agreed to Approve the Airport Expense Claims Report of November 30, 2023.

Commissioner Dinges reviewed the Monthly Budget Analysis Report for November 2023 and stated the 2023 Budget is in line with the projected percentage of 91.7% expenditures.

Commissioner Dinges reviewed the **Trial Balance Report for October 2023** and it can be available when requested in the Public Building Commission Office.

Commissioner Dinges reviewed the **2024 Flexible Annual Budget** and **5 Year Plan**. Upon a motion by Commissioner Dinges and second by Commissioner Lee, it was unanimously agreed to Approve the **2024 PBC Flexible Annual Budget** and the **5 Year Plan**. The total **2024 Flexible Budget** is \$32,925,055.00.

PBC Operations

Upon a motion by Commissioner Effinger and second by Commissioner Bouse, it was unanimously agreed to Approve the Jail Fire Alarm Replacement with JF Electric, at a cost of \$1,456,666.00.

Airport Operations:

Upon a motion by Commissioner Beach and second by Commissioner Effinger, it was unanimously agreed to Approve the **2024 Airport Budget**.

Upon a motion by Commissioner Effinger and second by Commissioner Bouse, it was unanimously agreed to Approve the MidAmerica St. Louis Airport **2024 Rates & Charges**.

Upon a motion by Commissioner Bouse and second by Commissioner Dinges, it was unanimously agreed to Approve the 3-year Service Agreement with Schindler Elevator Corp at a price of \$49,200.00 and two additional 1-year options at the Airport Director's Discretion.

Upon a motion by Commissioner Effinger and second by Commissioner Lee, it was unanimously agreed to Approve the FY2025-2029 Transportation Improvement Program for submittal to IDA.

Upon a motion by Commissioner Bouse and second by Commissioner Effinger, it was unanimously agreed to Approve the Change Order # 7 to Taxiway Lima and Taxiway Lima Bridge Project, with Plocher Construction for a cost not-to-exceed \$185,266.16.

Upon a motion by Commissioner Bouse and second by Commissioner Effinger, it was unanimously agreed to Approve the Supplemental Agreement 4 to Right of Entry No. 1/AMC/ROE/Scott-10-002 and authorize the Airport Director to execute the agreement.

Upon a motion by Commissioner Bouse and second by Commissioner Effinger, it was unanimously agreed to Approve the 8.25% rate increase to the Foley Building Maintenance hourly cleaning rate and outer building cleaning flat rate, and a 10% overhead charge for carpet cleaning contract oversight.

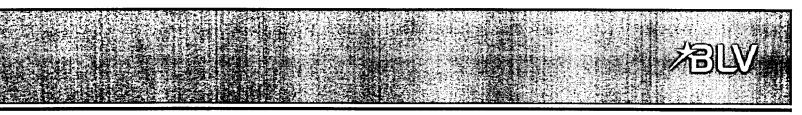

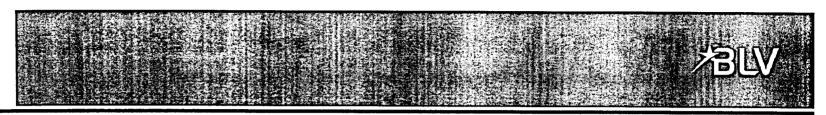


Airport Rates & Charges 2024

- ➤ US Customs and Border Protection Establish Federal Inspection Service Fee at \$5 per passenger





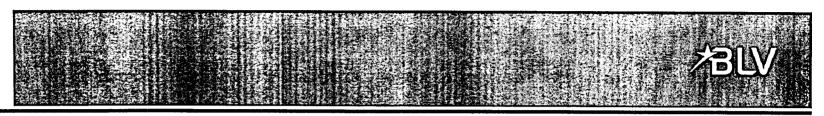
3. Elevator and Escalator Service Maintenance

The Airport issued an Invitation to Bid for Elevator and Escalator Service and Maintenance for various buildings at MidAmerica St. Louis Airport. The scope of the work includes inspection and service of the Passenger Terminal elevators and escalators and the Boeing Facility elevator including the annual state inspection for all. The proposed contract is for three years with an option for two additional one-year extensions. Two bids received were Kone, Inc. for \$71,020.00 per year and Schindler Elevator Corp. for \$49,200.00 per year.

<u>Financial Impact</u>: Project is budgeted in the Airport Operating Budget with some services reimbursed by Airport Tenants.

Motion: "Move to authorize the Chairman to approve a 3-year service agreement with Schindler Elevator Corp. at a price of \$49,200.00 per year, and two 1-year options at the Airport Director's discretion."





5. Taxiway Lima – Change Order #7

In February 2022, the PBC approved a \$37,513,287.00 construction contract for the Taxiway Lima and Taxiway Lima Bridge project. Several items have presented themselves which were outside of the original scope of the project. The work to be completed as part of this change order includes addition of two signs to meet a FAA recommendation, several maintenance and drainage improvements, and the addition of a swing gate for maintenance access. These items will result in a change of \$185,266.16, or 0.49% to the contract, which results in an overall cost increase of \$900,589.24, or 2.40% to the original contract.

<u>Financial Impact</u>: Project is 100% funded by state grants administered through IDOT and DCEO, and TIF funding.

Motion: "Move to approve and authorize the Chairman to execute Change Order #7 to Taxiway Lima and Taxiway Lima Bridge project with Plocher Construction Co. at a cost Not-to-Exceed \$185,266.16."





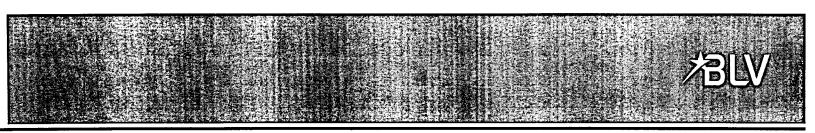
7. Foley Building Maintenance LLC Rate Increase

Foley Building Maintenance LLC provides janitorial services for MidAmerica St. Louis Airport as part of the County contract. MidAmerica St. Louis Airport has not provided a rate adjustment to the Foley Building Maintenance contract since 2016. Moving forward, the intent is to match the rate adjustment the County provides for the cleaning contract. For CY2024, the County rate adjustment is planned to be 4.4%. Due to the lack of previous adjustments, MidAmerica St. Louis Airport requests an 8.25% rate adjustment in CY2024, and will plan to match future County adjustments. Additionally, Foley will begin carpet cleaning contractor oversight for Millicare at an overhead rate of 10%.

Financial Impact: Rate increase and overhead is included in the CY2024 Airport Budget.

Motion: "Move to authorize the Chairman to approve an 8.25% rate increase to the Foley hourly cleaning rate and outer building cleaning flat rate, and 10% overhead charge for carpet cleaning contract oversight."
