Upon a motion by Commissioner Dinges and second by Commissioner Beach, it was unanimously agreed to approve the Regular Monthly Meeting Minutes and the Executive Meeting Minutes of March 26, 2024. Motion carried.

Upon a motion by Commissioner Effinger and second by Commissioner Dinges, it was unanimously agreed to approve the Resolution for Participation in State of Illinois Federal Surplus Property Program. Motion Carried.

### **PUBLIC BUILDING COMMISSION OPERATIONS**

Upon a motion by Commissioner Effinger and second by Commissioner Bouse, it was unanimously agreed to approve the Millennia Professional Services Proposal for St. Clair County New Animal Shelter - Engineering Proposal for a total price of \$54,200.00. Motion carried.

Upon a motion by Commissioner Effinger and second by Commissioner Bouse, it was unanimously agreed to approve Millennia Professional Services Proposal for Geotechnical, Documentation, and Materials Testing Services St. Clair County Animal Services Building\_Rev 1 for a total of \$26,177.00. Motion carried.

Upon a motion by Commissioner Bouse and second by Commissioner Effinger, it was unanimously agreed to approve the G & W Engineering Proposal to Provide Engineering and Consulting Services for St. Clair County Jail Generator at a cost of \$43,500.00 plus expenses estimated at \$1,000.00. ### **FAIRGROUND OPERATIONS**

Upon a motion by Commissioner Bouse and second by Commissioner Effinger, it was unanimously agreed to approve the revised Trane HVAC purchase for a difference of \$92,627.00. The approved amount is \$908,828.00. Motion carried.

Upon a motion by Commissioner Bouse and second by Commissioner Dinges, it was unanimously agreed to approve the Roof Bid Proposal with Joiner Sheet Metal and Roofing at a cost of \$1,850,757.00. Motion carried.

Upon a motion by Commissioner Effinger and second by Commissioner Bouse, it was unanimously agreed to approve G & W Engineering Storage Building Proposal at a cost of \$46,800.00 plus expenses estimated at \$1,000.00. Motion carried.

Upon a motion by Commissioner Effinger and second by Commissioner Bouse, it was unanimously agreed to approve G & W Engineering Entry Gate/Ticket Booth Proposal at a cost of \$24,600 plus \$750.00 for expenses. Motion carried.

### **AIRPORT OPERATIONS**

Upon a motion by Commissioner Effinger and second by Commissioner Bouse, it was unanimously agreed to approve and authorize the Chairman to execute the consulting services agreement for 1-year with Clayborne & Wagner LLP for a cost not-to-exceed \$ 96,000.00. Motion carried.

Upon a motion by Commissioner Bouse and second by Commissioner Effinger, it was agreed to unanimously approve and authorize the Chairman to execute the Fifth Amendment of the service agreement between MidAmerica St. Louis Airport and Republic Parking. Motion carried.

Upon a motion by Commissioner Effinger and second by Commissioner Bouse, it was agreed to unanimously approve Amendment 12 to the engineering agreement with CMT for the Terminal Modifications at a not-to-exceed cost of \$73,000.00 and authorize the Chairman to execute the agreement when appropriate. Motion carried.

Upon a motion by Commissioner Bouse and second by Commissioner Effinger, it was agreed to unanimously approve and authorize the Chairman to execute Change Orders 24 and 25 to Contract 2021-15, Non-AIP CMAR – Miscellaneous Terminal with Holland Construction. Change order #24 will not exceed \$176,435.64 and Change Order #25 will not exceed \$497,009.77. Motion carried.

Information only. The Airport has coordinated with Scott AFB and the maintenance and repair responsibilities for Taxiway Golf are scheduled for release to Scott AFB in May 2024 as originally scheduled.

Upon a motion by Commissioner Lee and second by Commissioner Beach, it was agreed to unanimously approve the utility easement between the MidAmerica St. Louis Airport and the City of Mascoutah with execution to occur contingent upon PBC legal counsel review. Motion carried.

### 1. Consulting Services – Clayborne & Wagner LLP

The MidAmerica St. Louis Airport desires to secure and engage Clayborne & Wagner LLP for support, representation, and legislative assistance in identifying and securing State and Federal funds for the MidAmerica St. Louis Airport. Additionally, to represent the Airport's interest before the State of Illinois, State Agencies, and other officials with the State of Illinois.

<u>Financial Impact:</u> The Clayborne & Wagner LLP consulting services agreement was included in the FY2024 Airport Budget.

<u>Legal</u>: Agreement was reviewed by PBC legal counsel and found to be legally sufficient.

Motion: Approve and authorize the Chairman to execute the consulting services agreement for 1-year with Clayborne & Wagner LLP for a cost Not-to-Exceed \$96,000.



# 2. Parking Service Agreement Amendment – Republic Parking

The purpose of the Fifth Amendment is to extend the parking service agreement for twelve months. During this period, the airport will evaluate selection and implementation of additional parking management technology, which will improve the customer experience and provide for greater revenue control and accountability.

<u>Financial Impact</u>: All parking revenue will be used to operate and maintain the airport. The financial obligations contained within the service agreement were included in the FY2024 Airport Budget.

<u>Legal</u>: Amendment was reviewed by PBC legal counsel and found to be legally sufficient.

Motion: Approve and authorize the Chairman to execute the Fifth Amendment of the service agreement between MidAmerica St. Louis Airport and Republic Parking.



### 3. Terminal Modifications Amendment - Crawford, Murphy, and Tilly

In August 2023, the PBC approved Amendment 10 to provide additional Phase 4 design services and in March 2024, the PBC approved Amendment 11 for Phase 4a Construction Phase Services, both with CMT. Due to several issues beyond the control of the airport or the consultant, the Passenger Boarding Bridges contractor exceeded the contract required completion by 55 calendar days (which resulted in a \$70,125 credit to that construction contract for liquidated damages). These delays resulted in increased Construction Phase Services fees. Total costs associated with these delays are accounted for in Amendment 12 at a cost not to exceed \$73,000.00.

<u>Financial Impact</u>: The overall project budget is \$34,053,135 with \$24,702,255 in funding from FAA grants. Additional grant funding is expected. The amendment is accounted for in the budget shown on next slide.

Motion: Approve Amendment 12 to the engineering agreement with CMT for the Terminal Modifications at a Not to Exceed cost of \$73,000.00 and authorize the Chairman to execute the agreement when appropriate.

### 4. Terminal Modifications – Non-AIP CMAR Change Order 24 & 25

In May 2021, the PBC approved a CMAR Agreement with Holland Construction for Non-AIP eligible work. Change Order 24 will address construction of a fence screening the north side of the TSA security checkpoint, the loading dock, and the employee parking lot from Air Terminal Drive. This fence was envisioned as part of the original design but is just now being implemented. Change Order 24 will not exceed \$176,435.64. Change Order 25 will address the gutter on the front of the terminal and two small roofs and a masonry cap on the rear of the terminal. The existing inlaid gutter system on the passenger terminal barrel roof is failing. Water is intruding into the building and damaging the east facing walls and columns. The two existing small EPDM roofs, above mechanical mezzanine spaces on the rear of the terminal, are original to the building and are at the end of their usable lifespan. The adjacent stone caps were discovered to have been leaking water. The proposed work would include covering the existing inlaid gutter and installing a new gutter system in the front, and removing the stone caps, replacing the membrane roofing with a 20-year warranty, and installing a metal roof coping instead of reinstalling the stone caps in the rear. Change Order 25 will not exceed \$497,009.77.

Financial Impact: The project is budgeted in the 2024 Airport Operating Budget (91700-999).

Motion: Approve and authorize the Chairman to execute Change Orders 24 and 25 to Contract 2021-15, Non-AIP CMAR – Miscellaneous Terminal with Holland Construction.

### 5. Taxiway Golf Transfer – Scott Air Force Base

Taxiway Golf is a 75' wide, 7,000' long taxiway which connects Runway 14L/32R to Runway 14R/32L. In April 2001, a DD1354 was finalized which transferred various pieces of real property from St. Clair County to Scott AFB. At the time, Scott AFB had concerns with the condition of the taxiway pavement above the East Drive Tunnels. St. Clair County/MidAmerica Airport was to maintain and repair the Crossover Taxiway (Taxiway "G") pavements from the Scott AFB boundary at the Silver Creek bridge to Station 44+00 which is just west of the East Drive tunnel area to conform to the requirements in FAA Federal Aviation Regulation Part 139. This commitment held for the design life of the pavement which is 25 years (May 1999 through May 2024). The Airport has coordinated with Scott AFB and the maintenance and repair responsibilities of Taxiway Golf are scheduled for release to Scott AFB in May 2024 as originally scheduled.

Financial Impact: No cost to Airport; elimination of maintenance/repair will result in a savings.

Motion: No motion necessary. This serves to inform the PBC of the action. Future easements may result from this action.



### 6. Airport Property Easement - City of Mascoutah

The MetroLink and Boeing Production Facility projects required extensions and relocations of existing utilities. To allow these extensions and relocations to occur, easements must be granted. In June 2022, the PBC approved several easements with Ameren for the Boeing Production Facility and MetroLink projects. In March 2024, the PBC approved an additional easement with Ameren for the MetroLink extension project. Since that date, another easement requirement has been identified. MidAmerica St. Louis Airport has been coordinating with the City of Mascoutah on this easement necessary for the MetroLink extension project. The easement will be 15-feet wide at the location identified on the following slides.


Financial Impact: No financial impact to the Airport or St. Clair County

<u>Legal</u>: The easement will be reviewed and approved by PBC legal counsel prior to execution.

Motion: Approve the utility easement between the MidAmerica St. Louis Airport and the City of Mascoutah with execution to occur contingent upon PBC legal counsel review.




