MINUTES:

A motion was made by Mr. Greenwald and seconded by Mr. Bittle to approve the minutes of the July 24, 2024, Trustee Committee Meeting. Motion carried.

2. TAX AGENT'S REPORTS AND RESOLUTIONS:

- a. Revolving Account Activity: The Revolving Account Activity Report for July 2024 shows a Beginning Balance of \$166,254.12, Receipts of \$2,915.28, Total Disbursements of \$62.07, Allocated Pool Interest in the amount of \$433.25 with a Balance at Month End of \$169,540.58.
