Ashley Report

Mr. Trentman: Reports from Ashley Jett, our AC Director.

Ashley: The month of November was pretty good for us. We have been able to start intaking a lot more dogs. We have been getting a lot more out through our adoption center so its been a lot easier for us when we actually have space for them to go. Our adoptions have picked up. We did 22 adoptions last month for the month of November and we were able to transfer 16 more dogs over there in the interim of that, or 16 more dogs or cats. We actually just moved another 6 dogs and 7 kittens over last week Wednesday. So we have some kennel space now and we could get an eviction where we could get some dogs that were abandoned in Cahokia. Once they open they are filling right back up. As far as the release rate goes, we are at 100% this month just with the amount of intakes as opposed to outcomes. We were able to help with a couple of owner surrenders last month. We were also able to figure out a couple of big stray dog problems that have been happening and trying to locate their owner. We did the Swansea huskies who have been causing a ruckus everywhere. We located their owners and we are going to try to help them. They have on the uppers of 12-15 dogs and 6-10 cats living inside of their house, so that's going to be a whole other situation but we are going to try to help them get rid of some of their, or control what they have. That's been pretty much it. We just finished up a Bisselll Empty The Shelter event, which finishes tomorrow and we will end up with 12 adoptions in the last 10 days, which is pretty good for us too. Our staffing is full. We have 3 new people on the adoption center, 2 full time and 1 part time. And also going through the process of hiring another warden as well. So she will be joining us in a couple of weeks hopefully. All is good, everybody is happy. We have more help, everybody is excited. They can all take om their own responsibilities, and we have more time to spend with all the animals, so its been good. Other than that, we don't have too much more.

Mr. Trentman: Well get me a list together of the material that you need and we can see if we can get someone to donate some materials.

Mr. O'Donnell: The class is like a 1:30 class, and one kid did most of it himself, so I'll pick it up then and I can drop it off somewhere too.

Mr. Trentman: Me and you will get it.

Ashley: Thank you.
