- ➤ St. Clair County Parks Grant Commission: Cycle 29 requests for payments have been processed during the last month on various projects.

 The Park Grants Commission recommends funding 21 grants for Cycle 30 in the amount of \$578,827.95, as itemized on the list provided, for your review and approval.
- > 2019 Special Park Projects: Requests for payments have been processed during the last month on various projects.
