# Report of Activities Emergency Readiness / Public Safety Committee November 2024 / December 2024

Per the St. Clair County EMA Report Herb Simmons presented the following,

- 1. All monthly radio tests were conducted, and no problems were noted.
- 2. Monthly tests of the outdoor warning sirens were completed. There was a power failure which caused the initial test of the system to fail. The problem was identified and corrected. A supplemental test was conducted and was successful. However, three sirens were confirmed not to activate on the successful test and the vendor is investigating those towers (One in Fairmont City, one in Freeburg and one in O'Fallon).
- 3. Attended the Monthly Starcom 21 Committee Meeting
- 4. Attended the STARRS Board Meeting.
- 5. Attended the Statewide Interoperable Executive Committee Meeting.
- 6. Attended meeting of the Statewide 9-1-1 Advisory Board.
- 7. Attended the monthly meeting of the St. Clair Special Emergency Services.
- 8. Siren Vendor Engineer and vendor working on punch list items for completion of the project.
- 9. Bi-weekly meetings continue with the FEMA BRIC Staff to develop the project application for St. Clair County and the 11 eligible communities. The application deadline is January 2025.
- 10. Attend monthly meetings of the Long Term Recovery Division of our County COAD (Community Organization Active in Disaster).
- 11. Working with IEMA and FEMA to continue the buyout program. Awaiting the next step of the process. IEMA has determined 37 of the homes that applied for buyout are located in a "special flood hazard area" which will allow expediting their process and that is underway.
- 12. Federal Disaster recovery centers have closed and the deadline to file for assistance is December 13, 2024. As of 12/6/24 below is a summary of assistance provided in St. Clair County:
  - a. 9,962 residents registered for assistance
  - b. 9,552 property inspections scheduled
  - c. 9,485 property inspections completed

- d. \$28,452,569.96 awarded in Individual Assistance \$14,494,397.20 awarded in Housing Assistance
  - e. \$13,958,172.76 awarded in Other Needs Assistance

### ST. CLAIR COUNTY SHERIFF DEPARTMENT

Lt. Colonel Thomas Knapp reported the following for the month of December 01, 2024, ending December 31, 2024, which included the following data: Average Daily Population was 435, inmates admitted 534 of those 266 were females, 395 were males, 189 misdemeanors, 266 felons, 5 Federal, 0 Transcor, and 53 fugitives. Sentence Weekend Bookings 1, Sentence County Bookings 8, D.O.C. 8 and Other 4. There were 168 traffic citations, 180 traffic warnings, 63 felony/misdemeanors/warrant arrests, 475 park patrols, 1182 business checks, and 45 courthouse checks, for a total of 983 points of contact with the general public.
