- 2) Authorize the removal and repair of two failing pavement joints on Greenmount Road using high early set concrete under emergency provisions to facilitate repairs as soon as possible. The contract to be

with Hemmer Construction in the amount of \$44,170.00. Project to be funded by the County General Highway Fund. Mr. O'Donnell made a motion seconded by Mr. Allen to approve. All members present voted aye.

- D) Resolution authorizing a contract with Hank's Excavation and Landscaping in the amount of \$49,533.00 for the improvements to Freedom Drive relating to the RR Crossing improvements, Section 24-19124-03-RR. Project to be funded by St. Clair Township RR Protection Fund Grant. Mr. Trentman made a motion seconded by Mr. Mosley to approve. All members present voted aye.
- E) Resolution allocating \$5,516,504.00 of Motor Fuel Tax funds to maintain streets in the year 2025. Mr. Mosley made a motion seconded by Mr. Hollingsworth to approve. All members present voted aye.
