Mr. Buehlhorn reported a porta toilet at Foley was pushed out on the lake. A section at Foley was cleared for trees to be planted by the highway department. On Friday morning the Silver Creek Entrance was torn during the snow and Silver Creek was closed until Tuesday. The gate has a \$29,000 bid price. At Engelmann there was a complaint brought in about off leash dogs that are dangerous and questioned who to call about them. Also mention wanting to remove trees at Engelmann. Mr. Buehlhorn also pointed out bids for grass cutting that have been received.

Joe Hemphill from Volkert reported that Ameren is working on getting power to the gate at Silver Creek. They are also revising the master plan documents.
