- 6. Attended the STARRS Board Meeting.
- 7. Attended the Statewide Interoperable Executive Committee Meeting.
- 8. Attended the Statewide 9-1-1 Next Generation 9-1-1 planning meeting.
- 9. Attended meeting of the Statewide 9-1-1 Advisory Board.
- 10. Attended the monthly meeting of the St. Clair Special Emergency Services.
- 11. Installation of new warning sirens continues. Crews are currently working in Smithton, Millstadt, and Hecker. The next phase will be O'Fallon and Shiloh.
- 12. EMA staff continues to work with FEMA on the BRIC grant program.
- 13. Attend bi-weekly meetings with the Long-Term Recovery Division of our County COAD (Community Organization Active in Disaster).
- 14. Working with IEMA and FEMA to continue the buyout program. FEMA provided a request for additional information on the project and that was submitted. Awaiting the hiring of an appraisal firm.
- 15. EMA Staff attended the NASCAR Planning meeting for the upcoming June NASCAR races at World Wide Technology Raceway
- 16. Staff had worked with East-West Gateway Council of Government Staff and IEMA to complete the update of the St. Clair County Multi-Hazard Mitigation Plan. St. Clair County has worked with all communities in the county to provide them the necessary information for their inclusion in the plan and this would allow them to continue to receive State and Federal assistance in the event of a disaster. It is requested that this board provide their support for the adoption of the updated plan as if finally approved by FEMA.

ST. CLAIR COUNTY SHERIFF DEPARTMENT

Lt. Colonel Thomas Knapp reported the following for the month of April 01, 2024, ending April 30, 2024, which included the following data: Average Daily Population was 368, inmates admitted 574 of those 137 were females, 437 males, 174 misdemeanors, 267 felons, 9 Federal, 2 Transcor, 82 fugitives. Sentence Weekend Bookings 17, Sentence County Bookings 9, D.O.C 9 and Other 5. There were 146 traffic citations, 66 traffic warnings, 49 felony/misdemeanors, warrant arrests, 332 park patrol, 1,041 business checks and 72 courthouse checks, for a total of 1077 points of contact with the general public.
