Ashley Report

Mr. Trentman: Reports from Ashley Jett, our AC Director.

Ashley: We do not have anything real pressing. Intakes are about the same as they were, we are pretty consistent for the year. Outcomes are pretty consistent for the year as well. Our adoptions are right about the same. We are doing 18-25 per month, so we are getting them out of there as fast as we can. Our transfers out of the building are still not as great as I would like them to be, but we at least did 16 this month so its better than the normal 4 that we have been having the last couple of months. We are full. We do not have very much space at all. Anytime we have a kennel open, we have another dog waiting to come in. And again consistently with more bite cases, more abandonments, mo police assists, more everything so its not getting any easier, that's for sure.

Mr. Trentman: Who pulled the animals this month?

Ashley: The majority of them were cats and they went across the street to the Humane Society.

Mr. Trentman: Not too much on dogs then right.

Ashley: Well, Gateway actually took a dog today. They traded with us. They had a dog that they needed to bring in to us so they took a dog from our kennels to make space. Then we have 4 that BAHS will be taking tomorrow.

Mr. Trentman: 4 dogs.

Ashley: Yes, 4 dogs and a cat tomorrow. We had a few go home today, so that opened a few spaces so we can finally go out and catch up on some of our calls, but we have not been able to do much. As far as anything else that has happened, we had a clinic just this last week. We have been hosting our low cost vaccine clinics monthly, and we have another one coming up in the month of November. This month we did 42 pets which was great. It's the biggest one we have had so far. It provides the service for people to come in and everybody is loving the fact that we are doing this. Its always positive. Thank yous as they are walking out the door, and that this is so great, please keep continuing. So that's nice. We just finished up with a Bissell event last month and we did 14 adoptions through that event. We have another one coming up in December so we will have another empty the shelters. It's a discounted adoption event that we have. The adopters pay a discounted fee and Bissell reimburses us the rest.

Mr. Trentman: I guess we are getting ready for Gifts from the Heart.

Ashley: Yes, we are getting ready for Gifts from the Heart. We have quite a few animals that we are wanting to take. So that will be nice. We have about 10 volunteers so far too. We should have enough people to be there and we will have it all set up and ready.

Mr. Trentman: When is that Mark?

Ashley: It's the 7th.

Mr. Trentman: The 7th?

Mr. O'Donnell: Next Thursday.

Mr. Trentman: At the fairgrounds. Alright Eddie. Whatcha got? Anything to add? How's it

going ?

Eddie: Its going good. I'll be glad when we get some more employees. We are just doing the

best we can.

Mr. Trentman: What did you do today?

Eddie: What did I do today? Where do you want me to start at?

Mr. Trentman: (laughing) That's what I'm asking. What's going on down there. You're busy.

Eddie: My days are the same. I do a little bit of everything. Just whatever they need me to do.

Mr. Trentman: Right on. We are lucky to have you. And Ashley too, and everybody else down there.
