Report of Activities Emergency Readiness / Public Safety Committee September 2024 / October 2024

Per the St. Clair County EMA Report Herb Simmons presented the following,

- 1. All monthly radio tests were conducted, and no problems were noted.
- 2. Monthly tests of the outdoor warning sirens were completed.
- 3. Attend the monthly Conference call with IEMA Director regarding COVID-19
- 4. Attended the Monthly Starcom 21 Committee Meeting
- 5. Attended the STARRS Board Meeting.
- 6. Attended the Statewide Interoperable Executive Committee Meeting.
- 7. Attended meeting of the Statewide 9-1-1 Advisory Board.
- 8. Attended the monthly meeting of the St. Clair Special Emergency Services.
- 9. Working with vendor to obtain right-of-way easements for installation of final outdoor warning sirens along with completion of secondary check of all installations. Next step will be working to install controllers in communities that requested to purchase a secondary controller.
- 10. Bi-weekly meetings continue with the FEMA BRIC Staff to develop the project application for St. Clair County and the 11 eligible communities. The application deadline is January 2025.
- 11. Attend monthly meeting of the Long Term Recovery Division of our County COAD (Community Organization Active in Disaster).
- 12. Working with IEMA and FEMA to continue the buyout program. Awaiting the next step of the process. IEMA has determined 37 of the homes that applied for buyout are located in a "special flood hazard area" which will allow expediting their process and that is underway.
- 13. Command Post was deployed to assist at Belleville Chili Cook Off.
- 14. EMA Staff attended the annual Illinois Public Safety Telecommunicator Association training conference.
- 15. Federal Disaster recovery centers remain open in Belleville and Cahokia. As of 10/15/2024 below is a summary of assistance provided in St. Clair County:
  - a. 5,223 residents registered for assistance
  - b. 4,891 property inspections scheduled
  - c. 4,115 property inspections completed
  - d. \$14,099,712.33 awarded in Individual Assistance

- e. \$7,300,601.59 awarded in Housing Assistance
- f. \$6,799,110.74 awarded in Other Needs Assistance

It was moved by G.W Scott Jr. and seconded by Mike O'Donnell There being no questions, motion carried, was approved to place on file.

#### ST. CLAIR COUNTY SHERIFF DEPARTMENT

Lt. Colonel Thomas Knapp reported the following for the month of September 01, 2024, ending September 30, 2024, which included the following data: Average Daily Population was 426, inmates admitted 613 of those 170 were females, 443 were males, 212 misdemeanors, 271 felons, 5 Federal, 8 Transcor, and 79 fugitives. Sentence Weekend Bookings 14, Sentence County Bookings 7, D.O.C. 9, and Other 8. There were 120 traffic citations, 59 traffic warnings, 53 felony/misdemeanors/warrant arrests, 469 park patrol, 881 business checks, and 22 courthouse checks, for a total of 940 points of contact with the general public.
