1. MINUTES:

A motion was made by Mr. Greenwald and seconded by Mr. Hollingsworth to approve the minutes of the August 21, 2024, Trustee Committee Meeting. Motion carried.

2. TAX AGENT'S REPORTS AND RESOLUTIONS:

- a. Revolving Account Activity: The Revolving Account Activity Report for August 2024 shows a Beginning Balance of \$169,540.58, Receipts of \$5,319.96, Total Disbursements of \$62.07, Allocated Pool Interest in the amount of \$446.87 with a Balance at Month End of \$175,307.41.
- b. **Payment Account Activity**: The Payment Account Activity Report for August 2024 shows a Beginning Balance of \$624,582.43 and a Balance at Month End of \$584,823.52.

5. OTHER BUSINESS:

Mr. Strohmeyer said item 237 located at 7125 Church Lane in East St. Louis is clearly burnt and needs to be demolished. Mr. Strohmeyer said the item needs to be removed from the auction list.

Mr. Mosley, Jr. said we originally were going to demolish the Spivey building but it has an adjoining wall with the Journal building which is owned by the City of East St. Louis. Mr. Mosley, Jr. said a developer would like to redevelop the area. Mr. Mosley, Jr. said they are looking to apply for a historical tax credit and submit preliminary applications to state and federal agencies for funding. Mr. Mosley, Jr. said they are looking for a letter of support from the committee that they would have the ability to use the parcels if approved. Mr. Strohmeyer said he talked with Neal Wallace who is the attorney about it. Mr. Strohmeyer said we wouldn't want to open ourselves up to liability issues if we sent a site control letter. Mr. Strohmeyer said we could let the City of East St. Louis take liability and they could handle it like they did with the hotel with this developer, or we can do a letter of support like Mr. Mosley, Jr. mentioned. Mr. Strohmeyer said the letter from the developer requested written correspondence from the site owner which would be the Trustee which is the trust for all the taxing bodies. Mr. Strohmeyer said he can start working on a letter of support tomorrow.
