# **New Business**

# A. Director's Report

Mr. Rick Stubblefield stated that Weatherization's two newly added contractors are off to a great start. They are helping us get caught up with the trouble with the new Weather Works system.

Mr. Stubblefield stated that Community Service Block Grant's new program year started in January. CSBG is moving right along, and funding is currently available for all their programs.

Mr. Stubblefield stated that LIHEAP has processed over 4,700 applications with a 91% benefits rate. Applications continue to come in at a steady pace. Theres is still some furnace assistance money available. LIHEAP is open until August 15<sup>th</sup> or when funding runs out. As you may have heard, all Federal LIHEAP staff have been terminated. Fortunately, 90% of the federal LIHEAP funds have been drawn for this year. We have been told that there will be no issues with getting the balance of funding and that those tasks have been transferred to another department.

Mr. Stubblefield stated that Community Development Block Grant's 5-year plan is under review and the 2<sup>nd</sup> round of public hearings will be held in May. The Disaster Recovery '22 award letters have been mailed out and contracts are being prepared. That was for \$30 million which was award to East St. Louis, Cahokia Heights, Caseyville, Dupo, and East Carondelet for flooding infrastructure. The Disaster Recovery '24 Grant agreement arrived and waiting for signature for \$89 million. IHDA application has been submitted for supportive housing. Continuum of Care Grant agreements for 2024 are starting to arrive. Public Facility applications for '25 are being reviewed.

Mr. Stubblefield stated that the Workforce Development Recognition event will be held tomorrow morning. It is always a nice event to recognize outstanding participants in the program. The One-Stop MOU and budget are complete and will be submitted by Friday.

Mr. Greenwald made a motion to approve the Director's report and Mr. Moore seconded the motion. The motion passed unanimously.
