1. Request Consent to Sublease Premises – AVMATS

AVMATS has operated both a Maintenance Hangar and a Paint Hanger located on the MidAmerica St. Louis Airport Golf Apron since May 31, 2003. The original Lease Agreement commenced on May 31, 2003 and had the initial term of twenty-five (25) years. The term expires in conformance with the lease as of May 31, 2028, with Lessee having the right to renew the lease for two (2) additional ten-year renewal terms. Pursuant to Section 901, Lessee may not assign the Lease or let or sublet the whole or any part of the premises without the express written consent of the PBC as agent for the County.

AVMATS seeks to sell its Maintenance and Paint Hangars. They have provided notification regarding the desire to initially sublet, and in the future, sell the premises to Mr. Joe Kehrer (private entity). AVMATS provided the necessary information outlined in Section 901 of the lease, to include identifying the sublessee's name, business address, proposed effective date of such sublet, the proposed sublet instrument, and to require the proposed transferee to provide financial information necessary for the County to determine financial ability to perform under the lease.

Financial Impact: No cost to the Airport. All revenue will offset Airport Operational Costs.

<u>Legal</u>: Information provided was reviewed by PBC legal counsel and found to be legally sufficient.

Motion: Approve and authorize the Chairman to provide consent for AVMATS to sublet their premises when appropriate, and approve Mr. Kehrer as a future purchaser.



2. IL Parking Excise Tax Reconciliation – Republic Parking

In May 2024, the Airport became aware of an Illinois Parking Excise Tax that became effective 1/1/2020 per 35 ILCS 525/10-1 et seq. and 86 Ill. Admin. Code Part 195. PBC legal was initially notified on 5/22/2024.

According to the statute, the "Operator" of a parking area is responsible for collecting and remitting the Parking Excise Tax to Illinois Department of Revenue (IDOR) as of 1/1/2020. The operator was made aware on 5/24/2024 and began withholding. In July 2024, the Airport directed Republic to collect the Excise Tax "on top" of the approved parking rates. A call with the Republic team took place on 11/12/2024 and they were asked to provide 4-years' worth of projected receipts and total tax that would be due. Republic initially offered to pay 25% of the amount owed. On 12/5/2024, the Airport Director recommended Republic take advantage of the IL Voluntary Disclosure Program (VDP) and enter into an agreement with IDOR. The VDP limited the look back period to four years, penalties would be abated, and any possible audit period would be limited to the 4-year disclosure period. The Airport countered with paying 25% of the reconciliation. Negotiation continued resulting in a 67%/33% split for Republic and the Airport respectively. On 5/28/2025 IDOR provided a letter of completion for the disclosure. Total paid by Republic under VDP was \$551,857.92 (including interest charges) with \$85,683.72 coming from collected Excise Tax May-Dec 2024. Of the remaining \$466,174.20, the Airport will reimburse Republic \$153,837.49.

Financial Impact: Funds from within the FY2025 budget will be reallocated to cover the Airport portion.

Motion: Approve and authorize the Airport Director to remit \$153,837.49 to Republic Parking as part of the Illinois Voluntary Disclosure Program reconciliation.



3. Pedestrian Crossing/Access Roads Rehab/Airport Blvd Widening - CMT

The 2022 Airport Master Plan identified a need to widen Airport Blvd and rehabilitate the Airport Access Roads as two projects titled Rehab / Widen Existing Airport Access Roads – Ph 1 and Rehab / Widen Airport Access Roads – Ph2, originally to occur in 2023. In December 2023, the PBC approved the selection of Crawford, Murphy & Tilly, Inc. (CMT) to complete the design of a variety of airport projects from 2024-2028. Two of the projects identified in that agreement were Rehab / Widen Existing Airport Access Roads – Ph 1 and Rehab / Widen Airport Access Roads – Ph2. In November 2024, the PBC approved the MidAmerica St. Louis Airport Transportation Improvement Proposal which included a FY 2025 project to design the projects with construction to occur in subsequent years.

The Airport coordinated with CMT and requested a Scope of Services and Fee proposal for the design. CMT submitted a scope of services and fee proposal of \$877,000 to complete preliminary design, design, and construction documents for entirety of the project broken out into three phases including the Pedestrian Crossing, existing pavement rehabilitation, and widening. At this time, the Airport is seeking only the preliminary design and engineer's report for the total project and the final design and construction documents for the pedestrian crossing (NTE \$300,000,00).

Financial Impact: Funding for this project was included in the FY25 Airport Operating budget.


<u>Legal</u>: The agreement will be reviewed and approved by PBC legal counsel prior to execution.

Motion: Approve an agreement with CMT to complete design services for the Airport Access Roads Improvements project at a cost NTE \$300,000.00 and authorize the Chairman to execute the agreement when appropriate.







Parking Revenue Trend








Car Rental Revenue Trend

Food & Beverage Revenue Trend




Fuel Sales (\$) & Fuel Gross Margin (\$) – Historical Trend


