Lt. Colonel Thomas Knapp reported the following for the month of February 01, 2025, ending. February 28, 2025, which included the following data: Average Daily Population was 427, inmates admitted 624 of those 184 were females, 440 were males, 240 misdemeanors, 262 felons, 12 Federal, 71 fugitives, and 3 Transcor. Sentence Weekend Bookings 11, Sentence County Bookings 7, D.O.C. 12 and Other 6. There were 133 traffic citations, 85 traffic warnings, 54 felony/misdemeanors/warrant arrests, 424 park patrols, 1131 business checks, and 36 courthouse checks, for a total of 849 points of contact with the general public.

Report of Activities
Emergency Readiness / Public Safety Committee
February 2025 / March 2025
Per the St. Clair County EMA Report Herb Simmons presented the following,

- 1. All monthly radio tests were conducted, and no problems were noted.
- 2. Monthly tests of the outdoor warning sirens were completed, and one siren had a problem in Fairview Heights, and it was fixed by the manufacturer.
- 3. Attended the Monthly Starcom 21 Committee Meeting
- 4. Attended the STARRS Board Meeting.
- 5. Attended the Statewide Interoperable Executive Committee Meeting.
- 6. Attended meeting of the Statewide 9-1-1 Advisory Board.
- 7. Attended the monthly meeting of the St. Clair Special Emergency Services.
- 8. Siren vendor continues to work on punch list items and change order. Progress continued slowly this month due to the weather.
- 9. The BRIC Application was filed by the deadline of 2/28/25.
- 10. Attend monthly meetings of the Long-Term Recovery Division of our County COAD (Community Organization Active in Disaster).
- 11. Three tornados struck St. Clair County on Friday 3/14/2025. An EF-1 tornado began in Monroe County and continued into rural Millstadt before lifting near Lower Saxtown Rd. An EF-1 tornado began in Northern O'Fallon and did substantial damage to the Parkview Trailer Park on Scott Troy Rd. An EF-2 tornado began in northern Mascoutah and continued into Clinton County and did substantial damage to farm properties in the area. All the areas were surveyed by EMA staff and information was relayed to IEMA regarding damage assessment. The greatest majority of properties were insured and repairs are underway. The new outdoor warning siren system functioned as designed and activated for 3 different warnings during the period and only activated those sirens within the polygon system. Substantial outreach was done prior to the storm striking utilizing social media along with the County Code RED system. This pre-warning allowed residents to be prepared to act upon the arrival of the storm. More than 1,500,000 people were reached utilizing the social media platforms.
