Upon a motion by Mr. Baricevic and seconded by Mr. Greenwald, it was unanimously agreed to approve Transportation Resolution #3015-25-RT – Authorizing i3 Broadband to Access County Right of Way to Install Communication Lines in Surrounding Neighborhoods off of County Highway 43, Shiloh-O'Fallon Road.

Upon a motion by Mr. O'Donnell and seconded by Mr. Greenwald, it was unanimously agreed to approve Transportation Resolution #3016-25-RT – Authorizing the Use of Portions of Saxtown Road and Bohleysville Road for the Cider Man Triathlon.

Upon a motion by Mr. Easterley and seconded by Mr. Greenwald, it was unanimously agreed to approve Transportation Resolution #3017-25-RT – Authorizing the County Engineer to Purchase Two (2) 2026 Tandem Dump Trucks in the Amount of \$380,000.

Upon a motion by Mr. Greenwald and seconded by Mr. Baricevic, it was unanimously agreed to approve Transportation Resolution #3021-25-RT – Authorizing the County Engineer to Sell or Dispose of Surplus Equipment.

Upon a motion by Mr. Baricevic and seconded by Mr. Greenwald, it was unanimously agreed to approve Transportation Resolution #3022-25-RT – Authorizing a Modification to the Agreement for the Widening of Green Mount Road with Oates Associates, Inc. in the Amount of \$101,58.

Upon a motion by Mr. Baricevic and seconded by Mr. Greenwald, it was unanimously agreed to approve Transportation Resolution #3023-25-RT – Authorizing a Permit to Calvary Pentecostal Church for an Entrance onto Hartman Lane.
