There were 18 Sentence Weekend Bookings, 2 Sentence County Bookings, 13 D.O.C. and 3 Other. There were 264 traffic citations, 286 traffic warnings, 87 felony/misdemeanors/warrant arrests, 492 park patrols, 1246 business checks, and 18 courthouse checks, for a total of 1006 points of contact with the general public.

Report of Activities Emergency Readiness / Public Safety Committee September 2025/ October 2025

Per the St. Clair County EMA Report Ann Barnum presented the following.

- 1. All monthly radio tests were conducted, and no problems were noted.
- 2. Monthly tests of the outdoor warning sirens were completed. During the month we received alarms on three of the outdoor warning sirens. ATI was notified and they sent a technician to investigate. One of the sirens was determined to have a faulty battery charger and it was replaced. The other two were determined to have their solar panels covered by foliage growth. The foliage was trimmed back and both sirens resumed normal reporting.
- 3. Attended the Monthly Starcom 21 Committee Meeting
- 4. Attended the STARRS Board Meeting.
- 5. Attended the Statewide Interoperable Executive Committee Meeting.
- 6. Attended meeting of the Statewide 9-1-1 Advisory Board.
- 7. Attended the monthly meeting of the St. Clair Special Emergency Services.
- 8. Staff attended the quarterly regional meeting for Illinois Emergency Management.
- 9. Attend monthly meetings of the Long-Term Recovery Division of our County COAD (Community Organization Active in Disaster).
- 10. Command Post Deployed to Belleville Chili Cookoff
- 11. Conducted the bi-monthly meeting of the Local Emergency Planning Committee (LEPC).
- 12. Continue to work with IEMA/FEMA on the Belleville and East Carondelet Flood Studies along with the Flood Buyout Program which is currently awaiting the appraisal process.
- 13. St. Clair County EMA was awarded STARRS (St Louis Area Regional Response System) grants for the purchase of a new Mobile Command Post Trailer, a towable generator, a towable light tower and a disaster response solar charging trailer. These were all previously submitted applications through the St. Louis UASI (Urban Area Security Initiative) that were no funded due to surplus monies awarded to the St Louis UASI this year.
- 14. Three citizens expressed their gratitude to Roy Mosley Jr. regarding the sense of safety they experienced during the chili cook-off.
